## 1. Introduction

Tourism Research Institute has compiled the 1<sup>st</sup> Quarter 2020 tourism sector performance report which highlights the following:

- International arrival statistics breakdown by nationalities
- International arrival statistics breakdown by points of entry
- Top 30 source markets
- Top 10 source markets 2020 1<sup>st</sup> Quarter in comparison with 2018 1<sup>st</sup> Quarter
- Regional markets performance for 2020 1<sup>st</sup> Quarter in comparison with 2019 1<sup>st</sup> Quarter
- International arrivals receipts
- Tourism performance projection 2020

The United Nations World Tourism Organisation(UNWTO) defines a tourist as a person traveling to and staying in places outside his/her usual environment for at least 24 hours and not more than one consecutive year for leisure, business and other purposes. Therefore, this report analyses all visitors arrivals spending between 24hrs and one year within Kenya.

## 2. Methodology

## 2.1 International Arrivals Data

The basic source of data for international tourist arrivals is the State Department for Immigration and Border Management captured through the PISCES (Personal Identification Secure Comparison and Evaluation System) software. Tourist surveys and other statistical approaches are applied to compute and verify variables like tourist demographic characteristics and purposes of visit.

## 2.2 International Tourist Receipts/Visitor Exports

Data on receipts and expenditure related to international tourism are generally gathered in the framework of the Balance of Payments under the items 'Services, Travel, Credit and Debit' (International Tourism Receipts and Expenditure)" UNWTO. The base for this is therefore the foreign exchange credit/balance of payment data from Central Bank of Kenya (CBK). UNWTO and World Tourism Travel Council (WTTC) guidelines/formulae are employed to estimate receipts that are not captured by CBK.

#### 3. International Visitors Arrivals

The total number of international visitors through all points of entry in the 1<sup>st</sup> Quarter 2020 was **389,590**. This represents a year on year decrease of **17.71%** compared to 1<sup>st</sup> Quarter 2019 when arrivals were **473,439**.

Arrivals through Jomo Kenyatta International Airport, Moi International Airport and other Airports registered highest percentage declines of **-16%**, **-44.02%** and **-59.79%** respectively. The other entry points most significantly the land borders registered the lowest decline of **-9.2%**.

#### 6. Tourism growth projections for 2020

International tourist arrivals had been projected to grow by 7.5% in 2020. However, the sector has been strongly hit by the effects of the outbreak of corona virus disease (Covid-19). To contain the virus and slow the spread, Kenya like many other destinations imposed an international travel ban from 25<sup>th</sup> March 2020. Source countries also imposed travel bans to and from their countries.

Indeed the tourism sector is one of the hardest-hit and affected by the pandemic with impacts on both travel supply and demand particularly from Kenya's top source markets.

#### 7. International Arrivals Receipts

International tourism earned Kenya kshs.35billion in the 1<sup>st</sup> quarter of 2020 against a projection of 42billion for the period. This represents a 10.38% decrease year on year since the earnings were kshs.39,051,615,000 for the same period in 2019.
